JC Promotions Policy

1. All work displayed must be original and created by the artist or under the artist's direct supervision. Work should be made by hand or with the use of appropriate tools.
2. All work must be completely finished. No kits, imports, items made from kits, unfinished work, items assembled from pre-manufactured components, embellished commercial objects, factory made items: T-shirts or sweats, silk flower arrangements. Only the type of work shown on your pictures is acceptable for display. JC Promotions, Inc. may require the removal of work considered to be in violation of these conditions and reserves the right to make final interpretation of all conditions.
3. Agrees to indemnify, defend, protect and hold harmless the sponsors, organization and all its associates, the proprietors of the location and all its associates, the municipality where the event is held at and all its associates, JC Promotions, Inc, its employees, agents and all its associates for any personal injury to himself/herself and his/her associates for any property loss or damages of any nature suffered by any person as a result of the operation of the above mentioned or the exhibitors and especially to the attendees while within the exhibitor's exhibit space or caused by the exhibitor. Exhibitor may not assign their contract for exhibit space or permit any other person to use part of such space.
4. Agrees should an accident occur within the exhibitors space caused by the exhibitor's display or debris left by the exhibitor, the exhibitor will be held liable in case of an accident. By applying to any events listed, the exhibitor agrees to save and hold harmless JC Promotions, Inc, its management, agents, employees, the municipality where the event is held, its management agents, employees, and sponsors from any liability resulting from such accidents.
5. Agrees to remove all boxes, paper and trash belonging to them upon vacating their space and to keep his/her space neat in appearance and in good order while selling.
6. Exhibitor's exhibit or product may not extend beyond the limits of Exhibitor's space.
7. Agrees not to sell food, beverages or anything edible at these events. Food and beverages will be available for purchase.
8. Provide own tables, chairs, racks and display materials unless otherwise noted. Rain or shine vendors are advised to come prepared for inclement weather, tarps, plastic covers, etc. All exhibit tables must be draped with attractive cloths with no boxes, extra merchandise or debris visible.
9. Exhibitor is entirely responsible for the collection and payment of any NJ state sales tax & for maintaining product liability. NJ Sales/Use tax-609-292-6400 or state.nj.us/treasury/taxation
10. Exhibitor agrees that the termination of this contract by the undersigned or the sponsor allows the sponsor to retain the total deposit as liquidation. No refunds, credits or transfers are due if contract or event is canceled.
11. Exhibitor is NOT allowed to take names/Addresses of event attendees. Inc. No dealers or sales representatives are allowed unless approved by JC Promotions.
12. Exhibitor agrees to remain open until closing time of event.
13. Agrees to read and be responsible to comply with all the rules and regulations in this contract.
14. Exhibitor may not sublet or apportion space to anyone else.
15. All art and craft items displayed must be for sale.
16. Exhibitors must comply with all applicable state and local laws regarding the sale of their work and with local fire codes with regard to flammability of booth and materials.
17. No tent stakes into street blacktop. Electric is not supplied. Only quiet generators will be allowed. You must inform us in advance if you will be using a generator.

The Jury Process Guidelines for Artisans and Crafters

1) All arts and crafts must be hand crafted by the exhibitor. Each should be individually handcrafted and not mass-produced.

2) All arts and crafts must be of excellent workmanship and design.

EXAMPLES OF CRAFTS THAT MAY NOT BE ACCEPTABLE ARE:

Products or pieces assembled from kits-Plastic beads or plastic canvas-Plastic and/or synthetic flowers-Manufactured or imported baskets-Excessive commercial lace on fabric items-Using hot glue as the primary method of attached parts.) Crafter must disclose any ready-made objects that they have enhanced. For example: tie-dyed t-shirts, towels, mass-produced vases, glasses, and the like that have been embellished, decorated or painted, beads and other jewelry parts that have been purchased and not hand produced.

3) Photography will be permitted with the following conditions:-It must be original photography of the exhibitor.

4) All arts/crafts will be juried. Exhibitors that add a new category of crafts after jury selection will still have to have the new item juried. EVERYTHING that an exhibitor wants to sell MUST go through this process. Please submit a description and examples of each item that you want to sell: high quality, recent photographs, digital files, PDF files of your work. Do not send multiple photos on 1 page, as it is difficult to determine the quality of the workmanship. If we need more info we will contact you. Thank you.

To apply for JC Arts & Crafts events you must send us a description of your work and pictures of your different items (close ups work best rather than a shot of an entire table) and of your display (indoor and outdoor set ups) along with this application or separately.

White or light beige canopies are preferred for JC's outdoor events.
